Demonstrated people and public speaking skills. Excellent oral and written communication skills. Appreciation and experience interacting with international audiences and foreign cultures. Preferred Qualifications: International industry related work experience, knowledge and expertise working in flour milling and grain processing. Able to lecture in Spanish.
